APPENDIX 3B – PARTIAL CONVERSION OF CONVERTIBLE NOTE

India Resources Limited (Company) has received a notice for partial conversion of A\$85,000 (US\$76,322) of the first convertible note issued to La Jolla Cove Investors Inc (La Jolla). In accordance with the terms of the convertible note, 7,870,370 ordinary fully paid shares have been issued to La Jolla.

The first convertible note has been fully drawn down and of the US\$1,500,000 face value of the second convertible note, the Company has drawn down a total of US\$250,000. Following this partial conversion, the balance outstanding under the first and second convertible notes is US\$470,169.
