APPENDIX 3B – PARTIAL CONVERSION OF CONVERTIBLE NOTE

India Resources Limited (Company) has received two notices for the partial conversion of a total of A\$190,000 (US\$185,968) of the convertible notes issued to La Jolla Cove Investors Inc (La Jolla). In accordance with the terms of the convertible notes, 16,058,707 ordinary fully paid shares have been issued to La Jolla.

Following these partial conversions, the first convertible note issued to La Jolla has now been repaid in full. The balance outstanding under the second convertible note is US\$481,577. The Company announced on 8 September 2010 that it had entered into an agreement for the early settlement of the balance of the convertible note facility with La Jolla.

Please find enclosed an Appendix 3B in relation to the issue of shares on part conversion of the convertible note.
