APPENDIX 3B – SHARE ALLOTMENT

In accordance with the terms of the Equity Line Facility Agreement (Facility) entered into with Chimaera Equity Market Neutral Fund (Chimaera EMN), the following ordinary fully paid shares in India Resources Limited (Company) have been allotted and issued to Chimaera EMN:

- (a) 11,921,965 shares in satisfaction of the commitment fee of 3% of the total commitment under the Facility; and
- (b) 19,311,797 shares issued as collateral shares as part of the security structure within the Facility, representing an amount equivalent to 5% of the total commitment under the Facility. During the term of the Facility, Chimaera can elect to pay the Company an amount calculated at 90% of the 15 day volume weighted average price of the Company's shares during a nominated redemption period.

The Facility was approved by shareholders at a general meeting of the Company held on 30 May 2011.

A further 967,190 ordinary fully paid shares have been issued by the Company in satisfaction of fees payable under a financing mandate agreement.

Please find enclosed an Appendix 3B in relation to the issue of shares pursuant to the Facility and the mandate agreement.
