APPENDIX 3B – PARTIAL CONVERSION OF CONVERTIBLE NOTE

India Resources Limited (Company) has received a notice for the partial conversion of A\$100,000 (US\$106,660) of the convertible note issued to La Jolla Cove Investors Inc (La Jolla). In accordance with the terms of the convertible note, 11,764,706 ordinary fully paid shares have been issued to La Jolla.

Following this partial conversion, the balance outstanding under the convertible note is US\$68,654. The Company announced in September 2010 that it had entered into an agreement for the early settlement of the balance of the convertible note facility with La Jolla.

Please find enclosed an Appendix 3B in relation to the issue of shares on part conversion of the convertible note.
